

In accordance with article 86 of Royal Legislative Decree 6/2015 of 30 October approving the Act on Road Traffic, the Circulation of Motor Vehicles and Road Safety (the Road Safety Act), **I HEREBY NOTIFY YOU of the opening of a penalty file** for an alleged violation of traffic regulations, by virtue of the report filed that appears on the other side of this page. In those cases provided for in article 89.2 of the Road Safety Act, notice of the fine may be issued subsequently to the opening of the file.

**INFORMATION:**

**Reporting Officer:** The Head of the fines and penalties department of the Local Network of Towns of the Provincial Council of Gerona (XALOC). You may appeal against the report based on the reasons provided for in article 13 of Royal Decree 1398/93 of 4 August and based on the reasons provided for in accordance with the regulations currently in force on the legal regime of the public sector. **Penalizing authority:** The Management of XALOC, by virtue of a decree by the Mayor's Office of the Town Council of Figueres on 21 January 2015, which was accepted in the plenary session of the Provincial Council of Gerona on 17 February 2015 on delegating competence for penalties, and pursuant to article 84.4 of the Road Safety Act.

In accordance with article 93.1 of the Road Safety Act, within the term of **20 calendar days following that of the notification of the fine**, YOU MAY:

- **Pay the reduced sum of the fine (50%):** This implies that you waive the right to present any allegations, and that the administrative procedure ends, with the contentious-administrative channel remaining open in conformity with article 94 of the Road Safety Act. Payment may be made at any of the banks indicated, or via the web [xalocgerona.cat](http://xalocgerona.cat)

- **Identify the driver responsible for the violation:** If you were not the driver of the vehicle at the moment for which the fine was issued, you may present a written statement at the General Register of this Town Council, or at any of the offices of XALOC, which you will find on the web <http://www.xalocgerona.cat/index>, indicating the name, surname(s), address and national identity document number. Non-fulfilment of this duty (article 11 of the Road Safety Act), except in the case of penalties for parking, shall entail the imposition of a fine for violation, under article 77.(j) of the Road Safety Act.

- **Present allegations and/or propose evidence:** You may present a written statement at the registers indicated, stating the file number, the date of the violation, and the registration number of the vehicle. Should you fail to present any allegations and to pay the reduced fine within the term of 20 calendar days, the report issued shall be considered to resolve the case, with the penalty to be duly executed within the term of the following 30 days, except in the case of those violations provided for in article 95.4 of the Road Safety Act.

**Deduction of points:** Should the violation entail the loss of points, the deduction thereof shall be carried out for the amount indicated on the other side of this page, within the term of the 15 calendar days following that on which the penalty becomes final (article 113 of the Road Safety Act).

"We hereby inform you that your details will be incorporated into a file created by XALOC for the management of penalties derived from non-fulfilment of municipal regulations. They shall only be transferred in those cases provided for in law. For further information and in order to exercise your rights of access, rectification, opposition against processing, and cancellation, you may address XALOC via any means."
